1. Improving Pakistan's Educational System

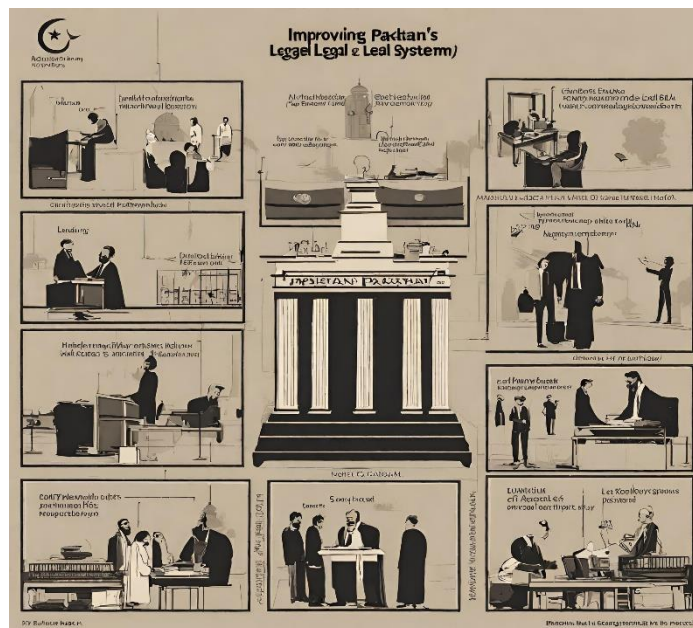
