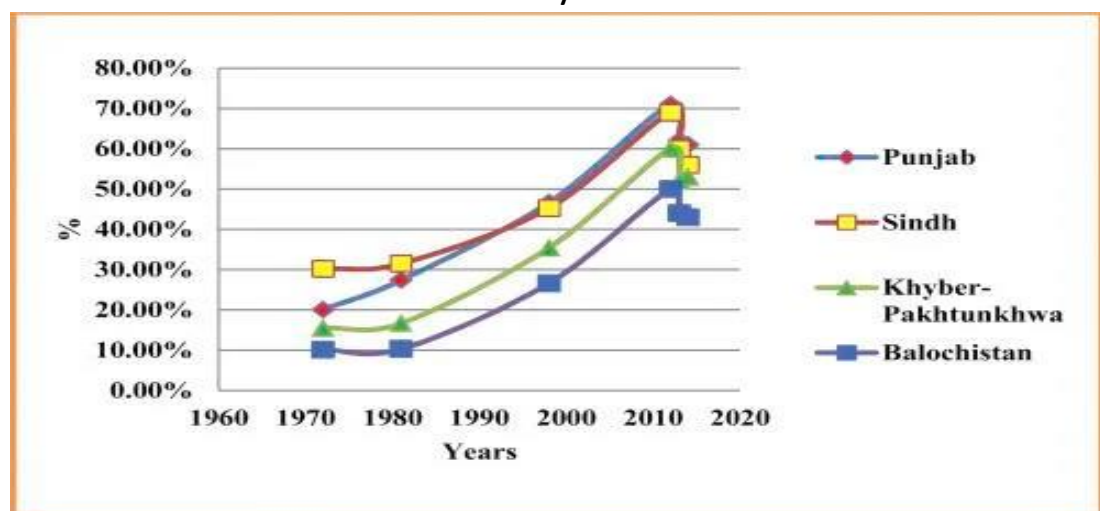

Implementing Sharia-compliant financial regulations to prevent market manipulation and speculative activities that contribute to inflation.

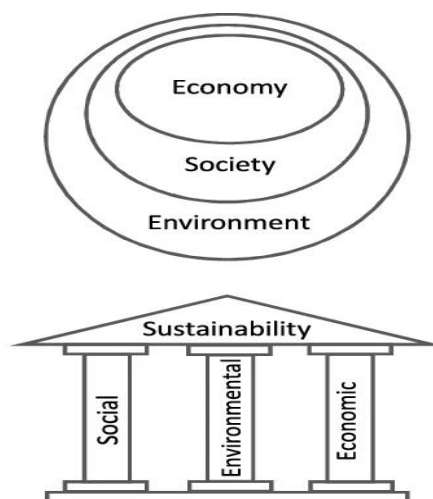
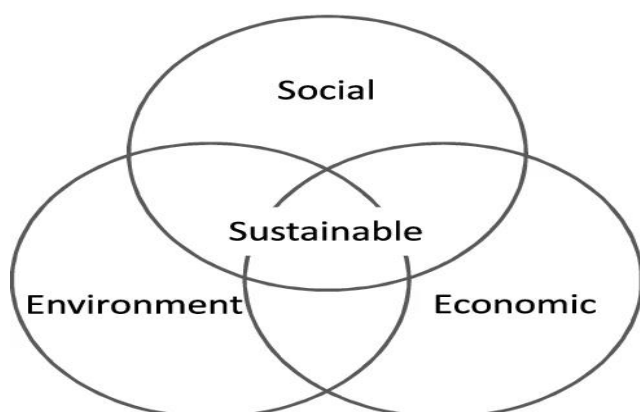
Emphasizing responsible resource management and environmental sustainability in economic activities.
